

# TypingDNA Terms of Use

## 1. Terms

By accessing the website at <http://typingdna.com> or its affiliated services (all TypingDNA applications and services), you are agreeing to be bound by these terms of service, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws. TypingDNA Service provides algorithms for identifying and authenticate users based on typing biometrics (also known as keystroke dynamics and typing patterns). It's used as a second-factor authentication and it's not recommended to be used as a single factor authentication. Only with the consent of the user, we learn the user typing patterns and based on user learning, we define and compute a match score (true/false value or in percentage; depending on use case).

TypingDNA does not guarantee perfect correctness, as none biometric id system provides. Using different device, keyboard or health condition (drunk, broken arm or any action that is substantially different) can affect the accuracy of TypingDNA matching.

If you use TypingDNA API service, you agree to require similar terms of use, provided by us, for your end users. Explicitly, you have to make sure your users understand and agree that their personal identifiable information, such as typing patterns, is recorded, stored and used.

## 2. Use License
